She has experience as a parliamentary legal adviser in constitutional matters for the Legislative Commissions of Justice and Human Rights; and of External Relations and Regional Integration, of the Salvadoran Legislative Assembly. She is an assistant researcher in the area of Comparative Constitutional Law at the Euro-American Research Center on Constitutional Policies (CEDEUAM, for its acronym in Spanish) of the University of Salento (Italy) and at the Center for Latin American Studies at the University of Bologna (Italy). He has done postgraduate studies at the Argentine University of Business Law (UADE) and the University of Salamanca (Spain), as



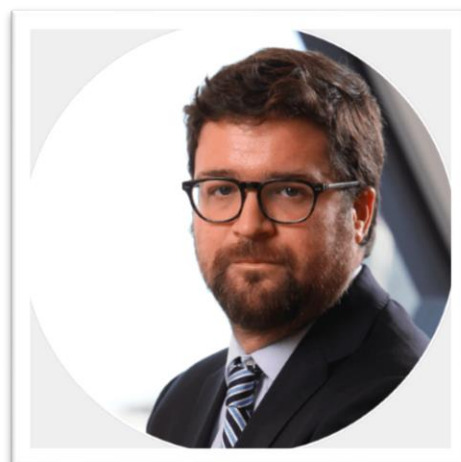

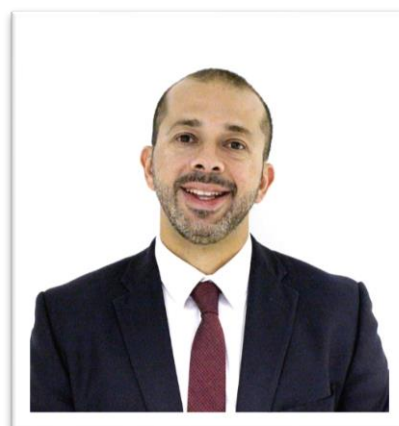
